Please see below for the questions received and the answers for the RFQ USCA12Q0124.

1. **Q. The wage determination provided referenced \$3.71 for health and welfare. Are non-government contracting companies required to provide this option?**

A. According to page seven (7) of the Wage Determination, *"All occupations listed above receive the following benefits: Health & Welfare: \$3.71 per hour or \$148.40 per week or \$643.07 per month."*

2. **Q. SOW Section C, 8.0/9.0: Is there parking available for the employee at the OPPTS National Training Academy or will the employee be responsible for their own parking fees?**

A. Per the requesting office, parking is available at no charge.

3. **Q. Quotation Preparation Instructions 5.2: Does the government require a separate summary table, apart from Table A, with the Price Quotation?**

A. No, the attached Table A is sufficient.

4. **Q. Is this RFQ open to Government Contractors under the 561320 or 561110 NAICS?**

A. The RFQ for Temporary Services is open to all eligible Offerors. NAICS codes are not applicable under Judiciary contracts.

5. **Q. The extended amount that I see on page 2 of 14, would that be the overtime rate? On page 15 with the extended price I am assuming that would be the hourly rate times the 1,040 hours?**
