Re: Brett Kavanaugh

Brief Statement of Facts:

Judge Brett Kavanaugh has engaged in conduct prejudicial to the effective and expeditious administration of the business of the courts by committing perjury, treating others in a demonstrably egregious and hostile manner, engaging in partisan political activity, making inappropriately partisan statements, and retaliating against others for participation in a complaint investigation process.

Judge Kavanaugh testified under oath that he didn't know the emails from Manuel Miranda contained information stolen from Democratic Senators including Senator Patrick Leahy. Judge Kavanaugh's testimony was "I was not aware nor did I suspect that information related to the Senate's judicial confirmations process had been obtained from Democratic computer files" and he testified that he did not recall receiving an email telling him they had a 'mole' providing secret information relating to nominations. Judge Kavanaugh's testimony is false because he did receive an email from Manuel Miranda with a subject line including the word "spying" and which informed Judge Kavanaugh that there was a mole within the Democrats' ranks. On May 9,

2006, Judge Kavanaugh testified under oath in answer to a question posed by Senator Durbin as follows: "I did not know about any memos from the Democratic side. I did not suspect that. Had I known or suspected that, I would have immediately told Judge Gonzales, who I'm sure would have immediately talked to Chairman Hatch about it. Did not know about it, did not suspect it." As can be seen in the attached copy of the email received by Judge Brett Kavanaugh from Manuel Miranda with a subject line: spying, and stating that there is a mole.

In addition to his perjury, Judge Kavanaugh made wildly speculative accusations against the Democratic party and Democratic Senators based on no evidence and just his own partisan ideology. Judge Kavanaugh treated Democratic Senators in a demonstrably egregious and hostile manner by accusing them of making up smears, accusing them of being fueled by pent-up anger about President Trump, accusing them of seeking revenge on behalf of the Clintons, accusing them of committing a coordinated character assassination, accusing them of trying to destroy his good name, and accusing them of vile threats of violence against his family.

Judge Kavanaugh engaged in partisan political activity through his inappropriately partisan statements attacking Democrats, and thereby making it clear that Democrats will not be treated fairly and equally when coming before him as a judge. His partisan activity while a member of the White House while now open and notorious most likely should not be taken as a violation of the rules since Judge Kavanaugh was a partisan employee at the time of those activities, however, his past role as a partisan is certainly evidence of his political position. The fact that he participated in the use of stolen emails during partisan hearings on judicial nominees, is evidence

that he is an overtly partisan individual who doesn't hesitate to bend or break the rules and laws to benefit his party.

Furthermore, his attacks on Democratic Senators were in response to the investigation of a complaint made against him by a former classmate for his sexual assault against her. Merely investigated whether or not he committed a serious felony was deemed by Judge Kavanaugh to be grounds to launch a verbal tirade against United States Senators in the United States Senate. There can be no doubt about how he will treat Democrats should they appear before him in his courtroom.
