Rules of Use for EPA Public User Group Members

The Administrative Office of the U.S. Courts (AO) will provide EPA Public User Group members with secure access to materials necessary for the work of the group, some of which may be deemed sensitive in nature. This information is provided for the purpose of enabling members to perform their duties.

The AO will be responsible for setting up and maintaining any necessary data repositories and access procedures. Group members must have their own computer and internet access.

As a member of the EPA Public User Group, I may access information provided by the AO or Judiciary IT systems. I agree to the following Rules of Use:

- Use materials provided solely to further the work of the EPA Public User Group.
- Respect the confidentiality of information deemed sensitive shared within the group. The intent of the AO is to make most, if not all, information shared and discussed with the group available to the public.
- Acknowledge and agree that any documents or other work products created in connection with the work of the EPA Public User Group are property of the AO, subject to review by the AO, and intended for public release at the AO's discretion.
- Consent to routine system monitoring when accessing information on data repositories provided by the AO and accessing Judiciary IT systems.
