Petitioner, Dr. Jan Barton Hamilton, a 77year old lesbian, a member of the US Supreme Court Historical Society was barred from attending and voting at the 2017 & 2018 Annual Meetings held in Chambers of the US Supreme Court. Dr. Hamilton had been previously harassed, intimidated and humiliated by an employee of the US Supreme Court Historical Society, Jennifer Lowe, at a reception following the Gideon v. Wainwright discussion on May 10, 2017. Then on June 4, 2017 Ms. Lowe canceled her banquet ticket. The Board of Trustees blocked Dr. Hamilton's attendance at the 2017 Annual Business meeting chaired by President Joseph P. Gregory. The physical assault with permanent bodily harm occurred on June 4, 2017 at about 3:00 p.m. following the 42nd Annual Lecture by President Emeritus John Sexton, "Warren Burger, The Court and Society" in the Chambers of the US Supreme Court. Dr. Hamilton reported the incident to U.S. Supreme Court Police Officers, Amy Smith and Sgt. Kim Gallagher with evidence of blood and bruising. However, no police records show the investigation was endorsed or recorded by Jeff Smith, US Supreme Court Chief of Police or Krista Graceio, Detective at the US Supreme Court. Thereafter, the Plaintiff sought 14th Amendment protection by Attorney Generals, Channing Phillips, Jessie Lui and Karl Racine. She asked that they represent her, a representative of the "The People" in the #MeToo epidemic. These government employees working under Color of Law refused to protect her, neglecting to enforce 18USC249, the Hate Crimes Act of 2009, 42 § 3631 and 18USC245, and basic fundamental constitutional rights 1st, 2nd, 4th, 5th, 6th, 8th, 11th, 13th, (Involuntary Servitude) 14th and 15th in addition to 18 18USC241, 42USC1983, 28 USC1334, 42USC1985, 1964 Civil Rights Act, Title II, VII & IX. When she filed the case at the District Court of Columbia for DC 1:17cv-01977-UNA she alleged and named all who were involved in the 2017 blockage of attendance at the Annual meeting. Due to IFP status, the clerk's office mailed the complaint and summons to the defendants. She filed a motion for a court appointed attorney with Judge Rudolph Contreas, to assist in preparing for a jury trial. Following denial, Dr. Hamilton filed a Notice of Appeal with the US Court of Appeals for DC. The Plaintiff pleads for Equal Justice Under Law alleging conspiracy to obstruct justice with criminal intent, bias and prejudice by the Board of Trustees of the US Supreme Court Historical Society, the Officers and Honorary Chairs and the US Supreme Court police, government employees, to include all operating under Color of Law, who refused to uphold the 14th Amendment to the US Constitution to investigate or arrest the perpetrators *Romer v Evans* (1996). This Writ of Certiorari also examines merits of Public Accommodation in DC, to show violations to Human Rights Act of 1977, as amended, D.C. Official Code Section 2-1401.01 et seq., (Act) District of Columbia; a petition of extraordinary circumstances which is appropriate and timely. The 2009 Hate Crimes Act, was passed by the US House and Senate and signed by the President. She therefore alleges that she is justified in seeking protection based upon, 18USC249, 42 § 3631 and 18USC245, her 11th and 13th (Involuntary Servitude due to mandated "Conversion Therapy") Amendment with 1st Amendment rights for Freedom of Religion and 14th Amendment Due Process and Equal Protection as an open lesbian protected by Romer v Evans (1996). She has medically documented permanent bodily damage

from Ms. Lowe's assault with black-outs. See pictures in Appendix TTT. She suffers from a stress induced bleeding ulcer that escalated to stomach cancer, a MALT Lymphoma. She is 77 and her future wife is 78, both have cancer. Suspension of Rules FRAP 2 is mercifully pled.

REASONS FOR GRANTING THIS WRIT OF CERTIORARI TO THE US SUPREME COURT, FILED OCTOBER 24, 2018 IN HONOR OF ALL WHO HAVE BEEN SUBJECTED TO SEXUAL HARASSMENT AND SEXUAL ASSAULT BY PERPETRATORS WHOSE LIKELIHOOD OF AN AXIS I TO AXIS V MENTAL ILLNESS DUE TO SADOMASOCHISM, PHOBIAS, BIAS AND PREJUDICE SHOULD BE SUBJECTED TO EVALUATION WITH APPROPRIATE DIAGNOSIS OF A POTENTIAL ALLEGED MENTAL ILLNESS

This civil RICO racketeering original cause of action created by 18 § 1964(c) applies in this case due to previously mandated "Conversion Therapy" with the racketeering assurance that she would be "cured of loving a person of the same gender and thus avoid criminal arrest." She completed the classes but was none-the-less arrested and spent over 2-years awaiting trial in solitary confinement in Pitkin County Jail in Aspen, Co. on a \$300,000.00 cash only bond. She was accused of being a "flight risk" for the 1st arrest of her life at age 65 by White Supremacist, Religious Extremists opposed to her lesbian lifestyle in a committed 4-year relationship with Nancy Lee Wall of Aspen, Co., her Chi Omega sorority sister. The defendants allegedly used this information to determine cause of action for their abrupt cancelation of her banquet ticket and membership in the US Supreme Court Historical Society.

The two women have shared matching engagement rings since 2006. Dr. Hamilton's late husband died June 10, 2018 and Ms. Wall is caring for her dying brother Charles R. Wall, retired Chief Counsel for Phillip Morris Intl. diagnosed with Alzheimer's. The mandated "Conversion Therapy" has been declared as racketeering in 7th Circuit JONAH case Michael Ferguson, et. al v. JONAH, et. al. (2015). Do LGBT families and women receive Equal Justice Under Law?
