Endnotes

- 1 Three-year-old caseload consists mostly of cases related to multidistrict litigation.
- 2 In August of 2022 the “Camp Lejeune Justice Act of 2022” was signed into law, giving the Eastern District of North Carolina (EDNC) exclusive jurisdiction and venue for actions filed under the action. To date 3,868 cases have been filed, and 3626 cases are pending. Those pending at least three years are reflected on this report.

Appendix B CJRA Inclusion Definitions

All active and senior district court judges, as well as all full-time and part-time magistrate judges, must report pending matters. Several issues relevant to the reporting of cases pending for more than three years include the following.

- With respect to cases pending for more than three years that have been assigned to district judges and magistrate judges from outside the districts where the cases originated, such cases are included in the totals for the districts where they were filed originally. Sometimes a block of cases or a class of cases that are similar in nature is assigned to a single judge. Such cases often require lengthy litigation when they involve complex issues and large numbers of parties.

Cases Pending More Than Three Years. The CJRA requires a report, by district judge and magistrate judge, of cases pending more than three years in the district courts. A case becomes pending as of the date the case originally was filed in the district court or the date the case was reopened, whichever is later. If a case has not been disposed of within three years after its filing date or reopening date, the case shall be reported as pending more than three years.

Note: A qui tam case brought under the False Claims Act (31 U.S.C. §§ 3729-3733) is “pending” as of the date on which the court first unseals the case.

Motions Pending More Than Six Months. The CJRA mandates a report enumerating all motions that have been pending six months or longer. A motion is a request made to a district judge or magistrate judge for an order, ruling, or similar determination. The opposing party has 30 days from the date of a motion’s filing to respond to it. A motion becomes pending 30 days after the date it was filed or was referred to a magistrate judge, whichever is later. If no decision on a motion has been filed within six months after the date the motion became pending, and the motion has not been referred to a magistrate judge, the motion shall be reported as pending more than six months before the presiding judge. If a motion is referred to a magistrate judge, the magistrate judge must file a report and make a recommendation for, or dispose of, the motion within six months after the date the motion became pending, or the motion shall be reported as pending for both the district judge and the magistrate judge.

Bench Trials Submitted More than Six Months. The CJRA requires the AO to prepare a report of bench trials submitted more than six months. In a bench trial, the judge (rather than a jury) decides the facts of the case. A bench trial is considered to be submitted on the date the courtroom proceedings are concluded. If a judge fails to file an opinion within six months after a bench trial was submitted, the bench trial shall be reported as submitted more than six months.

Bankruptcy Appeals Pending More Than Six Months. In accordance with an action of the March 1998 Judicial Conference, the CJRA now requires a report, by district judge and magistrate judge, of bankruptcy appeals pending more than six months in the district courts. A bankruptcy appeal becomes pending as of the date the appeal originally was filed in the district court or the date the case was reopened, whichever is later. If an appeal has not been disposed of within six months plus 60 days after its filing date or reopening date, the appeal shall be reported as pending more than six months.

Social Security Appeals Pending More Than Six Months. In accordance with an action of the September 1998 Judicial Conference, the CJRA now requires a report, by district judge and magistrate judge, of Social Security appeal cases pending more than six months in the district courts. A Social Security appeal case becomes pending as of the date of the filing of the latest transcript in such case. If a case has not been disposed of within six months plus 120 days after its filing date, the case shall be reported as pending more than six months.

Appendix C CJRA Exclusion Definitions

The following items are **excluded** from the CJRA report:

1. Motions in 2255 cases.
2. Motions in social security appeals.
3. Three-year-old civil cases, bankruptcy appeals, social security appeals, motions, or bench trials that are “stayed pending appeal,” or in arbitration due to an order issued by the court to compel arbitration pursuant to a court annexed Alternative Dispute Resolution (ADR) program, or the ADR Act of 1998.
4. Motions in multidistrict litigation cases (MDL).
5. Reports for motions and bench trials for newly appointed district judges and magistrate judges who have been on the court less than six months. But **bankruptcy appeals, social security appeals, and three-year-old civil cases must be reported for newly appointed district judges and magistrate judges.**

Note: Any district judge or magistrate judge appointed on or after **March 31** is considered a new appointment for the following September reporting period. Similarly, any district or magistrate judge appointed on or after **September 30** is considered as newly appointed for the following March reporting period.

6. Magistrate judges are not required to report motions if a report and recommendation, or disposition has been filed before the end of the reporting period.

Special Exclusions: In social security appeals, prisoner petition cases involving habeas corpus, and bankruptcy appeals, any motions for leave to appeal, or to proceed in forma pauperis (IFP) that was filed when the case was initially docketed is not reportable. If an additional or secondary motion is filed requiring a decision by the court, this should be **included** in the report.
